INSIDE OUT



To Provide Services, with Dignity and Respect, That Help People Become Self-Sufficient. <u>Executive Director's Update:</u>

- As I write this, the government is re-opening after a 16 day "partial shutdown". The politics in Washington lately are very contentious creating some uncertainty in relation to funding for our programs. At this point, the government is funded through Jan. 15th, including funding for our programs. The direct impact and timing of funding for our programs gets a little convoluted. For example, our Head Start program is funded through January 31st with funds from the previous Federal fiscal year. Therefore, there is a lag in timing from the Federal budget cycle and our grant cycle, providing us with a little bit of protection from being immediately impacted by budget decisions (or lack thereof) in Washington. Management by crisis seems to have become the norm in Washington, so there's a real possibility of another shutdown in January. As long as any future shutdown (and lack of funding appropriations) doesn't last for several weeks, our agency is in "good shape" to continue to operate programs and provide services to our community.
- The Salvation Army bell ringing campaign will be here soon, and planning has already begun. In Orleans County, the funds raised (over \$22K last year!) play a huge role in us being able to meet client needs. I ask that staff considerer helping out again by signing up for a time slot of bell ringing at Wal-Mart in Albion. Unfortunately, bell ringers must stand outside to ring the bell (Wal-Mart policy); therefore it's more difficult to get volunteers. If you are able to ring, plan for the weather conditions! As an agency, we will again this year allow staff up to 4 hours of paid time to ring bells during work time as long as it's approved by your supervisor and director and can be scheduled within you normal scheduled hours with minimal disruption to agency operations/services. Please contact Annette Finch for further information.
- Reminder: Vacation balance carry-over from one calendar year to the next is limited to 25 days. Unused time in excess of the limit will be lost. Please be sure to use your time!
- Congratulations to the CCR&R program staff on completing 100% of their milestones (again!) for their contract year that ended 9/30/13. Keep up the great work!
- We have an issue in the agency that we ask for everyone's help to improve. Our incidence rates of employee injuries is simply too high. As a result, our rates for Worker's compensation insurance have increased dramatically (by \$45,000) this year, negatively impacting budgets across the agency. Our total cost of \$160,000 is roughly \$60,000 higher than an employer of our size with a "normal" claims experience. That's \$60K that's unavailable to us for more pressing needs (think \$ for staff pay!). The program budgets most impacted are programs with high employee counts (i.e. Head Start), and programs with higher risk work (i.e. drivers for CATS, crew for Weatherization). AND, the cost of the insurance is only a portion of the cost to the agency. When an employee is injured, we have the cost of losing the services of a valuable team member who knows their job and often need to train someone else to carry their workload during their absence. AND, there's the financial problems faced by the injured worker, including delays in receiving compensation and reduced compensation during their absence. When an employee is injured, it's a lose-lose situation for everyone. How can you help? We need to be sure that we are all working in a safe manner. If you're lifting something, don't be a tough guy (or gal), ask for a hand. Be sure you and your coworkers are following safe work practices and agency policies, using personal protective equipment, etc. If you see a situation that's not safe, do something about it or report it to someone who can resolve the situation. If you have suggestions, forward them to your supervisor and/or the safety committee. The bottom line is that we need to try to raise the level of safety awareness in the agency and reduce the number and severity of injuries.

- On a positive note, we've received preliminary renewal rates for our Health Insurance for 2014. Rates are increasing by roughly 3%, which is the smallest % increase in at least 10 years. Further details will be provided when the rates are finalized.
- We are in the beginning stages of conducting our triennial Community Needs Assessment (CNA). Nate is spearheading the effort and is currently working with a workgroup of board members to steer the process. You will hear more details in the near future, and some staff will likely be asked to assist with surveys. The results of the assessment are used to steer decisions on provision of services and strategic direction for the agency. If you have thoughts on specific needs that you see in the community related to our mission, please feel free to shoot Nate and email for possible exploration in the assessment process. If you know of any information or data that would help, please let Nate know.

Tips for Lifting Properly

- If you are approaching a box and don't know what's in it, try moving it a little with your foot first to see how easily it moves. This will help you gauge how heavy the box is.
- Always wear nonskid shoes when you are lifting often or lifting potentially heavy objects.
- Never bend at the waist and lift the box up with your back. Keep your upper body straight and parallel with your lower legs. Grab the item and push up with your legs, not with your back.
- Never jerk your body around when lifting. You may feel fine after doing this once, but repeated occurrences can easily lead to injury in even the healthiest workers.

Your SNAP Benefits Are Changing

Why are my benefits changing?

Your benefits are changing for two reasons. First, your benefits are changing due to the cost of living. These changes happen every year. Second, your benefits are changing because increased benefits provided by a federal law called the American Recovery and Reinvestment Act of 2009 (ARRA) will expire on November 1, 2013.

When are my benefits changing?

On October 1, your benefits may go up a little bit due to changes in the cost of living. On November 1, your benefits will go down due to the end of the extra benefits provided by the 2009 law.

How much are my benefits going down on November 1?

Your benefits depend on many things like income, household size and expenses. So, it is hard to say exactly how your benefits will change. But if you live in a household of four and nothing else changes, your benefit would go down about \$36.

How can I eat healthy on a low budget?
